WHY THIS PRODUCT IS SO EFFECTIVE:

- This product is highly attractive to many ant species. The granules are carried directly into the mound by workers as food for the colony.
- Inside the mound, the bait is passed to the queen, as well as to other ants. By the end of one to four weeks, the queen and most of the ants in the mound will have eaten this product and died.
- When the queen is dead, no new worker ants can be produced, so the mound dies.
